## **Press Release for Events at North Hunterdon High School:**

On August 21, 2007 the NHHS administration met with Clinton Township Police representatives to review topics of mutual concern, including all safety procedures. The Hunterdon Central administrative staff members were also in attendance to review the first football game security procedures. The Clinton Township Police and North Hunterdon High School administrators remind all visitors to the North campus to park in designated parking spaces only. In particular, cars parked along the Route 31 campus access road can create a real hazard to the safety of all. Emergency vehicle access, including ambulances and fire trucks, can be hindered by cars illegally parked along the critical Route 31 entrance. Anyone who is not in compliance with traffic or parking ordinances will be subject to fines or towing. Be reminded that Regional Road and Beaver Brook cannot accommodate overflow parking. Below are other issues that were discussed and agreed upon in the meeting:

### School-age children:

From this point forward, any children/students wishing to attend North Hunterdon High School functions must either:

- Present a student ID from the North Hunterdon High School District
- or present a student ID from the opposing team's school district
- or be accompanied by a parent or responsible adult (all elementary school-aged children fall into this category)

### Traffic Regulations:

- Park only in designated lots.
- Do not park on roadways that do not have designated parking slots.
- Do not block access to the facility by restricting traffic through the two circles, i.e. double and triple parking.

Police and Security:

- The Clinton Township Police Department and North Hunterdon Security will be present at major events. The North Hunterdon athletic department will have approximately 25 staff members which include security, ticket takers and administration at football games . Hunterdon Central High School will also have there own security and administrative personnel at the first football game.

Off-site designated parking locations:

- Additional parking is available at Union Township School. A 54 passenger bus will offer transport to North.
- Drop off at the school will be in the District parking lot.

Tailgating:

- Tailgate parties before, during, or after any student activity or event at North Hunterdon High School are not permitted.

Tobacco and Alcohol:

- Tobacco and alcohol in any form are prohibited on the North Hunterdon High School campus. Police may issue summonses or arrest those who ignore these statutes.

Pets on property:

- Dogs and other pets (except guide animals) are prohibited on school property.

Dress Code:

- North Hunterdon High School's dress code will be in effect at all athletic events and student activities.

Sportsmanship:

- The use of noise making devices, inappropriate language, taunting, baiting or unsportsmanlike conduct, directed at opposing players, officials, coaches, or fans is contrary to the spirit of fair play and sportsmanship the community of North Hunterdon High School expects.
