From Northern New Jersey

Take Interstate 80 West to exit 19 in Allamuchy, make left on to Route 182 South. Take Route 182 to Hackettstown. In Hackettstown make right on to Route 46. Take Route 46 east for approximately two miles to the intersection of Route 57 west. Take Route 57 west for approximately nine miles and make left on to Route 31 South. Take Route 31 South for approximately 10 miles. Cross over Interstate 78; make right at Country Club Drive. Take first left; proceed past Ingersoll Rand Building. **Enter 1465 lobby and take elevator to Fifth Floor.** The Arc is located at the end of the hallway.

From Southern New Jersey

From the Camden/Deptford Area:

Take Interstate 295 North for approximately 40 miles to Interstate 95 South. Take 95 South to exit 4 for Pennington/Route 31 North. Make right on to Route 31 North; continue for approximately 21 miles. Take jug handle for Country Club Drive. Cross Route 31 and make first left turn. Proceed past Ingersoll Rand Building; enter 1465 lobby and take elevator to Fifth Floor. The Arc is located at the end of the hallway.

From the Southern Jersey Shore Area

Take the Garden State Parkway to Exit 7 for the Atlantic City Expressway. Take the Atlantic City Expressway North west until it becomes Route 42. Take Route 42 North until it connects with Route 295 North. Proceed with the same directions as from Southern Jersey.

From Eastern New Jersey:

From the Morristown/Livingston Area:

Take Interstate 287 South for 18 miles to exit 21B to Interstate 78 West Take Interstate 78 West to Exit 17 Route 31 North, Take Route 31 North for one mile to the jug handle to County Road 626 for 31 South - Clinton/Flemington. Go over an overpass (Onto old Route 22) and make a left at the first light which is Center St. Proceed straight to stop sign; make a right on to 31 South. Cross over I78; make right turn at first intersection for Beaver Brook Country Club. Make first left turn. Go past Ingersoll Rand Building. Enter 1465 lobby and take elevator to Fifth Floor. The Arc is located at the end of the hallway.
