**TO THE PARENT:**

In order to request permission for a student to wear a parent-purchased helmet for any VHS interscholastic athletic activity, this form must be completed and signed by the student and his/her parent(s) or guardian(s) and submitted along with all helmet labels and warranty information attached. **A copy of this form must be given and approved by the Head Coach and the Head Coach will give to the Athletic Administrator.**

The form must be on file in the athletic office before the student will be permitted to wear the parent-purchased helmet. In order for permission to be granted, the helmet can be New (receipt of purchase has to be provided) or if previously used must have proof of reconditioning date/approved by the head coach to match team colors and must meet all applicable standards of the National Operating Committee on Standards for Athletic Equipment (NOCSAE). The helmet must match those worn by teammates, and the team coach must determine that permission for your son or daughter to wear the parent-purchased helmet will not lead to team disunity.

**REQUEST / WAIVER AND RELEASE**

We hereby request permission for \_\_\_\_\_ [name of student] to wear the helmet identified above, for the sport and season noted above, instead of the helmet issued by the Voorhees High School (“VHS”) Athletic Department. We acknowledge that the VHS Athletic Department offered a helmet to the student for his/her use during participation in the athletic activity, including all practice sessions and competitions. However, due to special circumstances and for reasons unrelated to the helmet offered by the VHS Athletic Department or the quality or condition of that helmet, we hereby decline the offer of that helmet and waive any and all rights we, or any of us, may have to the VHS Athletic Department-issued helmet.

We, and each of us, hereby agree to waive, release and hold the North Hunterdon-Voorhees Regional High School District Board of Education and its employees, agents and representatives (“Board”) harmless from any and all claims, demands, actions, causes of action, costs, suits and liabilities of any kind or character whatsoever, whether known or unknown, suspected or unsuspected, in law or in equity, which we or any of us may hereafter have against the Board, arising out of or relating to use of the helmet identified above. This Waiver and Release shall bind each and all of us and the successors and assigns of each or any of us, and shall inure to the benefit of the Board.
