Dear Parent/Guardian,

We would like your son or daughter to have a wonderful time at the Homecoming Dance therefore, the following guidelines will be in effect:

1. Once an individual leaves VHS, he or she will not be readmitted to the dance. Students must stay in the mall and cafeteria area while in attendance, and are not to wander throughout the school.
2. Anyone consuming, possessing or under the influence of alcohol and/or other drugs will not be permitted to attend or remain at the homecoming dance, and will be handled in accordance with board of education policy. Also, law enforcement will be notified.
3. Proper attire (cocktail dresses, dress pants, etc.) must be worn for the duration of the dance. No caps, sneakers, jeans or shorts will be allowed.
4. All the VHS rules apply.

If any students are directed to leave the dance, the following procedures will be followed:

1. Parents or guardians will be notified immediately by telephone.
2. Depending on the severity of the infraction, local law enforcement officials may be contacted.
3. School authorities will be notified of the infractions on or before October 10, 2022.

In order to be eligible to buy a ticket for the Homecoming Dance, your student must be in good academic standing and free from all outstanding obligations. If your student owes money for an obligation, please have prior to purchasing a ticket. Payments should be submitted to the Athletics Office (see Mr. McGeehan) during normal school hours or at time of purchase. Any student who earned less than 30 credits during the previous school year (excluding current freshmen) is not eligible to attend this dance based on the North Hunterdon-Voorhees Board of Education Policy 2430.

Please complete, sign, and return the bottom portion of this notice as well as the "Student Random Alcohol Consent Form" when you purchase your tickets for Homecoming. Each ticket cost **\$25.00** and will be **on sale before school the week of September 19 - 23, 2022**.
